C. Shapard - Denver South hosted Sierra Nevada and DAT this morning for our partnership meeting. Sierra Nevada adding another 900 jobs in the region, and DAT hiring 200.

K. Smith - Update- Arapahoe County has received \$9.8 million in Emergency Rental Assistance funds. So, please direct anyone in need due to COVID to us.
